In Case of Death: At the death of a Brother Knight, notify the Grand Knight or the next in charge, who will then contact the family and offer sympathy and help from the Council. ## **Lloyd Joseph Schultenover**

Lloyd Joseph Schultenover, 88, formerly of Spring Valley, MN and Estero, FL passed away peacefully at Harvest of Roanoke in Roanoke, TX on Wednesday, June 23rd, 2021.

Lloyd was born January 11, 1933 in Melrose, MN to Frances and Isadore Schultenover. He was the 4th oldest of 10 children. He graduated from St. Cloud Cathedral High School in 1951. On October 15th, 1955 he married Marjorie (Laubach) Schultenover. They were married 60 years before the passing of Marge in 2015.

Lloyd attended St. John's University in Collegeville, MN for 1 year and Dunwoody in Minneapolis studying carpentry and building design before joining the Army in 1954. He was stationed in TX, CA and even the Antarctic for 1 year. Lloyd met Marge in 1954 on a blind date. They married shortly after in 1955. Lloyd and Marge began their life together in Sartell, MN where Lloyd worked for Cathedral High School doing maintenance work. A job at a lumber yard brought them to Milfred, IA and then to Mason City, IA where he learned more about the lumber industry becoming a manager there. When the opportunity came up in 1971 to purchase Spring Valley Building Center in Spring Valley, MN, Lloyd and Marge jumped at it and owned it together until they sold it in 1998. Lloyd was an active member of the community and was a member of the Kiwanis Club and St. Ignatius Catholic Church. He was also an avid golfer and played in the men's league at the Root River Country Club.

Lloyd and Marge also spent many summers at their lake home on Pearl Lake. When they retired they divided their time between Pearl Lake in the summer and Estero, FL in the winter. They loved their life in FL in the sunshine playing golf, euchre and visiting with their many friends and family. Lloyd had a quick wit and a great sense of humor that will be missed by all who knew him. He was very generous and kind and worked hard his whole life creating a great life for his family.

Lloyd is preceded in death by his loving wife, Marge. He is survived by daughters Beth (Tom) Behrens of Rochester, MN, Amy (Craig) Barth of Roanoke, TX, and Kim (David Sinner) of Minneapolis, MN, and son Paul Schultenover of Owatonna, MN.

A memorial service will held at Holy Cross Catholic Church, 10651 County Road 8, Kimball, MN on Tuesday August 17th at 11:00am, visitation beginning at 10:00am. Burial and reception to follow.
