Resolution Regarding Transfer of Funds from Council 10498 Treasury

Whereas Article VII, Section 3 of the By-Laws of Council 10498 requires that:

"No money in excess of \$500.00 shall be paid or transferred from the Treasury of this Council, (except such moneys as the Council is called upon to regularly pay for its current expenses and as provided by the Laws and Rules of the Order or for purposes approved by the Supreme Council or Board of Directors), unless by a two-thirds vote of the members present and voting at a regular business meeting held subsequent to a regular business meeting at which notice in writing of a resolution of intention to pay or transfer such money and the purposes and amount to be paid or transferred shall have been given and regularly read."

And

Whereas Article VII, Section 4 of the By-Laws of Council 10498 requires that:

"All bills shall be presented to the Recorder and by him read to the Council before being referred to the Board of Trustees. In case a bill is not approved by the Board of Trustees, it shall be referred back to the Council for action."

Be it resolved that:

Approval of the annual Council budget (which includes items of expense in excess of \$500.00) by a two-thirds vote of those present at a regular business meeting held subsequent to a regular business meeting at which the annual Council budget (which has been approved by the Board of Trustees) has been presented in writing, shall be deemed to fulfill the requirements of Section 3 and 4 of Article VII of said By-Laws for the fraternal year for which the budget is presented.
