In Case of Death: At the death of a Brother Knight, notify the Grand Knight or the next in charge, who will then contact the family and offer sympathy and help from the Council. The Council member contacting the family should ask whether a wake will be held and if so, whether the family would like the Council to do a rosary service. Any ceremonial presentation requested should be done only with permission of the clergy. If the deceased Brother is a 4th Degree member, the Grand Knight will notify the Insurance Field Agent and the Faithful Navigator of the Assembly.

Formerly of Baltimore, MD and Ocean City, MD he had been a resident of Estero since 1998. Leo was born June 21, 1929 in Calvert County, MD a son of the late Charles W. and Edna M. (Jett) Berger.

Several Council Knights attended the annual fundraiser for the Immokalee Pregnancy Center, a very worthy pro-life charity caring for the genuine needs to mother and child in Immokalee. Visit <u>https://www.immokaleepregnancy.com/</u> for more details.

Attendance at the annual prayer & praise at the Unborn Child Memorial at Palm Royale Cemetery and Mausoleum in Naples. The speakers were excellent. They included Dr. Karysse Trandem, medical director of PRC in Ft Myers and Naples. In our public witness and advocacy at Planned Parenthood in Ft Myers (ongoing), we direct many women to the local PRC office on Plantation. Dr. Trandem highlighted the 4 major medical risks to women from abortion, derived from a summary of thousands of medical studies completed by researchers who are both "pro-life" and "pro-choice". These risks include, in priority order:

- A 40% increase in the probability of breast cancer in women who have had only 1 abortion
- A significant risk of uterine hemorrhaging and other complications of the uterus
- Potential for an adverse impact to the cervix, resulting in higher risk of premature delivery of future children
- An 81% increase in the probability of emotional and mental health issues, including depression, anxiety and suicidal ideation

For supporting evidence of the above risks, I recommend a review of the film "Hush", at <u>https://hushfilm.com/</u> and related statistical data compiled by Dr. Joel Brind of NYU. The film, co-produced by a "pro-choice" woman, yields startling evidence of the suppression of these study results from Dr. Brind and others by professional organizations including the AMA.
