From the Pro Life Office

Hello Brother Knights, The Spring 2022 40 Days for Life campaign in Ft Myers has concluded. Thanks to all fellow Knights who have participated, in private, personal prayer or public prayer. For the global 40 Days for Life program, we can report the following results to date:

- 21,000 babies saved (that we know of)
- 114 abortion facilities closed
- 229 abortion workers have converted and left their "work"

Did you know there is a group of Catholic men and women in Ft Myers who pray publicly from 9AM to 1PM *every* day that Planned Parenthood is open. This is the United Vigil for Life, and you can find them at 6418 Commerce Park Dr Mon-Fri during those hours. In Case of Death: At the death of a Brother Knight, notify the Grand Knight or the next in charge, who will then contact the family and offer sympathy and help from the Council. The Council member contacting the family should ask whether a wake will be held and if so, whether the family would like the Council to do a rosary service. If a Mass will be offered, the family should be asked if they would like a resolution of condolence to be presented. Any ceremonial presentation requested should be done only with permission of the clergy. If the deceased Brother is a 4th Degree member, the Grand Knight will notify the Insurance Field Agent and the Faithful Navigator of the Assembly.
