A motion by council 10498 member Brent Labreche was made for approval to vote on a resolution which was regularly read at our business meeting of 9/6 regarding making an investment exceeding \$500 from the council treasury the Catholic Education Assistance Fund whose purpose is for providing educational scholarships for children of council 10498 members as well as other councils in Lee and Collier county. The motion was voted on and passed at that meeting so that voting for adoption of the resolution can proceed after this publication.

In accordance with council by-laws, this proposed resolution must be published to all members and voted upon at a subsequent meeting with approval by two-thirds of the members present to achieve adoption.

Here follows the resolution:

Whereas money allocated to the current Scholarship Fund of the council is going unused,

and

Whereas money allocated to the current Scholarship Fund of the council does not receive any investment return on fund allocated,

and

Whereas many members of councils in the area including our own have received benefits well over \$100,000 from the Catholic Education Assistance Fund during the 15 years of its existence, and Whereas the Catholic Education Assistance Fund has been managed and overseen by members of the Order locally using donations and investments to maintain its original principal value,

and

Whereas it is the desire of the council to provide as many scholarships as possible to the children of members of the local fraternal community,

Be it resolved that the current amount in the council treasury allocated to scholarships (approximately \$ 6953) be transferred to the Catholic Education Assistance Fund for use in providing scholarships in accord with its guidelines.

In Case of Death: At the death of a Brother Knight, notify the Grand Knight or the next in charge, who will then contact the family and offer sympathy and help from the Council. The Council member contacting the family should ask whether a wake will be held and if so, whether the family would like the Council to do a rosary service. If a Mass will be offered, the family should be asked if they would like a resolution of condolence to be presented. Any ceremonial presentation requested should be done only with permission of the clergy. If the deceased Brother is a 4th Degree member, the Grand Knight will notify the Insurance Field Agent and the Faithful Navigator of the Assembly.
