> witness, we have been present since Tues afternoon, October 4th in smaller numbers. OLOL parish has been represented on Tues. afternoons, from 12 to 4PM by parishioners, some Council Knights, and a loyal student parishioner from FGCU. We have also been blessed with the presence of parishioners from both Resurrection parish and St. Columbkille parish. Our prayers and presence have been augmented by the ongoing work of the local group United Prayer Vigil for Life and the national organization Sidewalk Advocates for Life. In fact, in the two weeks from Fri., Oct 14 to Tues., Oct 25, four individuals who arrived for

services chose to seek services from one of our partner organizations, rather than patronize Planned Parenthood. Please note that Planned Parenthood recently reported they have become the provider of approx. 40% of abortions in the US as of their latest 2020-2021 annual report.

Finally, there will be a closing ceremony on Sunday, Nov. 6, at 1:30PM on the sidewalk at the Planned Parenthood of Ft Myers, 6418 Commerce Park Dr. Parking is available nearby for those interested in attending.

Supreme Chaplain Archbishop Lori issues statement on behalf of US Bishops

Last week, Archbishop William Lori, Supreme Chaplain of the US Knights of Columbus, speaking on behalf of the U.S. bishops, emphasized the damage that abortion causes.

"As pastors who deal daily with the tragic impacts of abortion, we know that abortion is a violent act which ends the life of preborn children and wounds untold numbers of women," Lori's statement said. "The Catholic Church wishes to continue in our work with our government and leaders to protect the right to life of every human being and to ensure that pregnant and parenting mothers are fully supported in the care of their children before and after birth."
