At this month's general membership meeting, a motion was made and carried to consider a resolution to change the By-Laws of the Council and to vote on these changes at the September 2006 general membership meeting. Please see attachment to this newsletter for the wording of the proposed changes.

A second motion was made and carried to vote on a resolution stating that approval of the Council 2006-2007 Budget at the September 2006 general membership meeting would give prior authorization by the membership for transfers of funds from the Treasury in excess of the current limits of Article VII. Sec.3 of the By-Laws (\$200). Approval of this resolution would allow transfers of funds from the Treasury to the limits of the line-item amounts in the Expenses section of the Budget without a special vote for approval of

## Knights for Life

Supreme Knight Carl A. Anderson on July 19 thanked President Bush for vetoing H.R. 810, the so-called "Stem Cell Research Enhancement Act," which would have, for the very first time, provided federal funds for research in which human embryos are destroyed.

"This stem-cell bill is eminently worthy of President Bush's first veto," Anderson said. "It would provide federal funding for the very first time for research involving the deliberate destruction of living human embryos, a practice that is terribly wrong. It is profoundly immoral to create human life in order to destroy it, whatever the theoretical benefit might be. Actual benefits from stem-cell research have thus far come entirely from ethical research on adult stem cells, which has produced dozens of successful therapies for a variety of diseases.

"Every human life, no matter how small, should be protected in law. Unfortunately, in America the destruction of unborn human life is perfectly legal, whether in a laboratory or in an abortion clinic," Anderson continued. "This bill would add insult to injury by forcing the taxpayers to pay for the destruction, and that is unconscionable."

Anderson concluded, "President Bush has done the right thing in vetoing this measure, and it appears that his veto will not be overridden. The Knights of Columbus, one of the largest pro-life organizations in the world, appreciates the President's action, and calls upon members of Congress to focus on stem-cell research that does not violate basic human dignity."

At the death of a Brother Knight, notify the Grand Knight or the next in charge, who will then contact the family and offer sympathy and help from the Council. The Council member contacting the family should ask whether a wake will be held and if so, whether the family would like the Council to do a rosary service. If a Mass will be offered the family should be asked if they would like a resolution of condolence to be presented. Any ceremonial presentation requested should be done only with permission of the clergy. If the deceased Brother is a 4th Degree member, the Grand Knight will notify the Insurance Field Agent and the Faithful Navigator of the Assembly.

**Resolution to Change the By Laws of Our Lady of Light Council No. 10498 of the Knights of Columbus presented at August 3, 2006 Membership Meeting**

**WHEREAS** Our Lady of Light Council 10498 of the Knights of Columbus wishes to

- 1) increase the annual dues paid by Honorary Members from \$9 to \$10
- 2) change the compensation given the Financial Secretary from 8% to 5% of the money collected on dues
- 3) explain the terms of elected and appointed officers
- 4) simplify the election process by removing the exception and using a simple majority to elect
- 5) remove the organist from the list of appointive officers selected by the Grand Knight
- 6) remove the requirement for additional bonding of the Treasurer and Financial Secretary by the Council
- 7) remove the words "before each meeting" from the requirement that the Grand Knight file with the Recorder a list of candidates to be balloted on at any meeting
- 8) change the time for meetings from 8:00 PM to 7:30 PM and the date of the second meeting of the month from the third Thursday to the last Thursday
- 9) in the case of meetings scheduled on legal or religious holidays change the date held to the following Thursday for the first meeting and to the preceding Thursday for the last meeting
- 10) allow approval of applications for membership at meetings by voice vote instead of by ballot unless there is a not a clear aye or nay for the candidate
- 11) allow the Treasurer to deposit moneys received from the Financial Secretary at other secure institutions of deposit in addition to banks and clarify that checks written on the Council must have two signatures
- 12) change the limit from \$200 to \$500 for non-current funds allowed to be transferred from the Treasury without a two-thirds approval at a general membership meeting of a proposed amount previously read at a preceding general membership meeting
- 13) remove the requirement that bills be presented to the Recorder and by him read before the Council before being given to the trustees for approval for payment and instead read to the Council by the Grand Knight after trustee approval
- 14) increase the size of the "Relief Fund" from \$100 to \$3000 and the maximum individual assistance from \$25 to \$500
- 15) regarding funerals and services for deceased member, remove references to a Memorial Committee and change actions taken by the Council regarding family of deceased member and permission of clergy
- 16) Change the times for Corporate Communion

**BE IT RESOLVED THAT:**

- 1) Article I. Section 3. Be changed to read:

"Each member shall pay annual dues. The same to be payable quarterly in advance at the first regular meetings in July, October, January, and April. The annual dues of members shall be \$25.00, excepting insured members under 26 years of age whose dues will be half that (\$12.50), honorary members who shall pay \$10.00, and honorary life members who shall pay nothing. Except as above stated, the dues of associate and insurance members shall be the same."

- 2) Article I. Sec. 4. Be changed to read:

The officers shall receive annual compensation, payable in quarterly installments at the end of each quarter, as follows:  
Financial Secretary: from the council an amount equal to 5% of the moneys collected on account of dues from both insurance and associate members, payable in quarterly installments at the end of each quarter.

- 3) Article II. Section 1. Be changed to read:

"(A) All Officers of the Council with the exception of the Financial Secretary, Lecturer and Chaplain shall be elected annually, by ballot. The annual election of officers shall take place at a regular business meeting held between May 15<sup>th</sup> to and including June 15<sup>th</sup> of each year, and with the exception of the Financial Secretary (assigned by Supreme to 3 year term) and the Trustees who shall serve for terms not to exceed 3 years as provided for by Section 145, and said officers shall hold their offices for the term of one year from the first day of July following their election and until their successors are duly elected and qualified.

(B) Not less than 2 months before the annual election, the Grand Knight shall appoint a Nominating Committee of three, who shall prepare a slate of candidates for the elective council offices. This slate shall be presented to the council not later than the regular business meeting preceding the meeting at which annual elections are to take place. Other nominations may be made from the floor and nominations may not be closed until the election meeting has convened and the members are ready to ballot."

- 4) Article II Sec. 2. Be changed to read:

"The election of officers shall be by ballot. A majority of all the votes cast shall be necessary to elect."

- 5) Article III. Sec. 3. Be changed to read:

"The appointive officers shall be as follows: Financial Secretary, Lecturer and Chaplain.

The Financial secretary shall be appointed by the Supreme Knight.

The Chaplain shall be selected by the Grand Knight, Deputy Grand Knight and Board of Trustees, in accordance with any rules established by the Bishop of the Diocese. The Grand Knight shall select the Lecturer."

- 6) Article III. Sec. 4. (Delete Section.)

- 7) Article III. Sec. 6. Be changed to read:

"Except when notice of application shall be published as provided by Section 110 of the Laws and Rules, it shall be the duty of the Grand Knight, as early as practicable, to file with the Recorder a list of candidates to be balloted upon at any meeting."

- 8) Article IV. Section 1. Be changed to read:

"Regular meetings of the council shall be held on the first and last Thursday of each month. The first meeting each month shall be a regular business meeting. All meetings shall commence at 7:30 PM. Twelve members shall constitute a quorum at business meetings."

9) Article IV. Sec. 8. Be changed to read:

"If the first meeting of the month shall fall on a legal or religious holiday, said meeting shall be held on the second Thursday of the month. If the last meeting of the month shall fall on a legal or religious holiday, said meeting shall be held on the next to last Thursday of the month. The Council by vote at a previous meeting may annul a meeting or fix a different date for a meeting."

10) Article V. Section 1. Be changed to read:

"Applications for membership in the Council shall be read at the beginning of each meeting by the Grand Knight, Membership Director, or other presiding officer. Members will be allowed time for discussion of each application and a voice vote will be taken after discussion is completed. If the voice vote does not show a clear aye or nay for the candidate, then a paper ballot system will be used. The Grand Knight will assign two tellers to collect and tabulate the paper ballots and the final result of the ballot will be presented to the council. The final yes or no vote tabulation will not be presented to the council and the ballots will be destroyed."

11) Article VII. Sec. 2. Be changed to read:

"The Treasurer shall deposit all moneys received from the Financial Secretary in a secure institute of deposit, to the credit of the council. Disbursements from this fund shall be made only by check signed by the Grand Knight and Treasurer. Two signatures will be required on all checks written on the account of the Council. The depository institution shall be furnished with a copy of this section."

12) Article VII. Sec. 3. Be changed to read:

"No money in excess of \$500 shall be paid or transferred from the Treasury of this Council, (except such moneys as the Council is called upon to regularly pay for its current expenses and as provided by the laws of the order or for the purposes approved by the Supreme Council of Board of Directors), unless by a 2/3 vote of the members present and voting at a regular business meeting held subsequent to a regular business meeting at which notice in writing of a resolution of intention to pay or transfer such money and the purposes and amount to be paid or transferred shall have been given and regularly read."

13) Article VII. Sec. 4. Be changed to read:

"All requests for transfer of funds will be presented to the board of Trustees, and after approval by the Trustees be presented to the Grand Knight for presentation to the Council. In case a bill is not approved by the Board of Trustees, it shall be referred to the Council for action."

14) Article VII. Sec. 5. Be changed to read:

"The sum of \$100.00 shall be paid from the General Fund to the Financial Secretary and shall be known as the "Relief Fund". The "Relief Fund" shall be for the purpose of rendering mutual aid and assistance to the Council's sick disabled and or needy members, widows or families, or families of deceased members. Additional funding of 5% of the net proceeds from all Council sponsored fund raisers, or any amounts from private donations, shall also be transferred to the fund. When the fund reaches a total cap of \$3000.00, additional funding shall cease. When after reaching \$3000.00, the fund falls below that amount, additional funding shall commence until the fund again reaches \$3000.00. Funding will commence whenever needed to maintain the fund balance of \$3000.00. No additional funding shall be made when the Fund has a balance of \$3000.00.

The Grand Knight, Treasurer, and Trustees shall constitute a Relief Committee. They shall investigate the case of any brother, or surviving member of a brother's family, who is reported to be in distress, or in need of relief, and if in their judgment, the case is one deserving of assistance, they shall have power to draw from this Relief Fund such reasonable sum of money to afford assistance as the circumstances of the case may require, provided, that in no single case shall more than \$500.00, or half the existing amount in the fund, whichever is less, be paid out without reference to and approval of the Council."

15) "Article VIII. Section 1. At the death of a brother Knight, the Grand Knight or the next in charge, must be contacted, who will then contact the family and offer sympathy and help, inquire as to whether a wake service will be held and whether the family would like the Council to do a rosary service at the wake. The family should also be asked whether a Mass will be offered and if they would like the Council to present a Resolution of Condolence at the Mass. Rosary services and Condolence Resolution presentation can only be done at the request of the family and with permission of the Clergy.

The Council (GK) or (FS) will notify the Insurance Field Agent and the Faithful Navigator if the deceased brother is a 4th degree member.

Article VIII. Sec. 2. The Council shall arrange for the celebration during the month of November of each year of a Mass or the Repose of the souls of the deceased members and shall cause five days notice to be given to the members of the time and place of such Mass. The Mass shall be celebrated by the Chaplain unless he is indisposed."

16) Article VIII. Sec. 4. Be changed to read:

"Once per quarter, the Council will receive Holy Communion as a body at a time and place to be voted on by the Council."
